TRADE DESCRIPTIONS ACT 2011

TRADE DESCRIPTIONS
(MARKING OF SAFETY GLASS FOR MOTOR VEHICLES) (AMENDMENT) ORDER 2017

IN exercise of the powers conferred by paragraph 29(1)(b) of the Trade Descriptions Act 2011 [Act 730], the Minister makes the following order:

Citation

1. This order may be cited as the **Trade Descriptions (Marking of Safety Glass for Motor Vehicles) (Amendment) Order 2017**.

Amendment of paragraph 1

2. The Trade Descriptions (Marking of Safety Glass for Motor Vehicles) Order 2017 [P.U. (A) 295/2017], which is referred to as the “principal Order” in this Order, is amended in subparagraph 1(2) by substituting for the words “1 May 2018” the words “1 October 2018”.

Amendment of paragraph 3

3. Subsubparagraph 3(b) of the principal Order is amended by substituting for the words “1 May 2018” the words “1 October 2018”.
